# **Personal Condition and Safety Equipment**

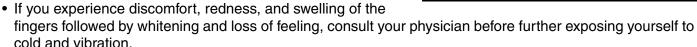
**Extended Operation / Extreme Conditions** 

#### **A** CAUTION

Prolonged exposure to cold and/or vibration may result in injury. Read and follow all safety and operation instructions to minimize risk of injury. Failure to follow instructions may result in painful wrist/hand/arm injuries.

It is believed that a condition called Raynaud's Phenomenon, which affects the fingers of certain individuals, may be brought about by exposure to vibration and cold. Exposure to vibration and cold may cause tingling and burning sensations, followed by loss of color and numbness in the fingers. The following precautions are strongly recommended, because the minimum exposure, which might trigger the ailment, is unknown.

- Keep your body warm, especially the head, neck, feet, ankles, hands, and wrists.
- Maintain good blood circulation by performing vigorous arm exercises during frequent work breaks, and also by not smoking.
- Limit the hours of operation. Try to fill each day with jobs where operating the unit or other hand-held power equipment is not required.

#### **Repetitive Stress Injuries (RSI)**

It is believed that overusing the muscles and tendons of the fingers, hands, arms, and shoulders may cause soreness, swelling, numbness, weakness, and extreme pain in those areas. Certain repetitive hand activities may put you at a high risk for developing a Repetitive Stress Injury (RSI). An extreme RSI condition is Carpal Tunnel Syndrome (CTS), which could occur when your wrist swells and squeezes a vital nerve that runs through the area. Some believe that prolonged exposure to vibration may contribute to CTS. CTS can cause severe pain for months or even years.

To reduce the risk of RSI/CTS, do the following:

- Avoid using your wrist in a bent, extended, or twisted position.
   Instead try to maintain a straight wrist position. Also, when grasping, use your whole hand, not just the thumb and index finger.
- Take periodic breaks to minimize repetition and rest your hands.
- Reduce the speed and force with which you do the repetitive movement.
- Do exercise to strengthen the hand and arm muscles.
- Immediately stop using all power equipment and consult a doctor if you feel tingling, numbness, or pain in the fingers, hands, wrists, or arms. The sooner RSI/CTS is diagnosed, the more likely permanent nerve and muscle damage can be prevented.



#### **Cutting Angle Adjustments**

 Only adjust cutting blade angle with unit flat on the ground, with the engine stop switch in the "STOP" position. Never adjust cutting angle with unit standing upright.

#### **Avoid Contact With Gear Box Assembly During Use**

 Gear box assembly becomes hot during use. Avoid contact with gear box assembly when using unit or making cutting angle adjustments.

- Check unit for loose/missing nuts, bolts, and screws. Tighten and/or replace as needed.
- Check that the cutting attachment is firmly attached and in safe operating condition. Dull, loose or damaged blades should not be used.

#### **A** WARNING

Moving parts can amputate fingers or cause severe injuries. Keep hands, clothing and loose objects away from all openings.

- ALWAYS stop engine, disconnect spark plug, and make sure all moving parts have come to a complete stop before removing obstructions, clearing debris, or servicing unit.
- DO NOT start or operate unit unless all guards and protective covers are properly assembled to unit.
- NEVER reach into any opening while the engine is running. Moving parts may not be visible through openings.

# **EMISSION CONTROL (EXHAUST / EVAPORATIVE)**

#### EPA 2010 and Later and/or C.A.R.B. TIER III

The emission control system for the engine is EM (engine modification) and, if the second to last character of the Engine Family on the Emission Control Information label (sample below) is "C", "K", or "T", the emission control system is EM and TWC (3-way catalyst). The fuel tank/fuel line emission control system is EVAP (evaporative emissions). Evaporative emissions for California models are only applicable to fuel tanks.

An Emission Control Label is located on the engine. (This is an EXAMPLE ONLY, information on label varies by engine FAMILY).

#### **Product Emission Durability (Emission Compliance Period)**

The 50 or 300 hour emission compliance period is the time span selected by the manufacturer certifying the engine emissions output meets applicable emissions regulations, provided that approved maintenance procedures are followed as listed in the Maintenance Section of this manual.



**DESCRIPTION HCA-266** 

- POWER HEAD Includes the Engine, Clutch, Fuel System, Ignition System and Recoil Starter.
- 2. THROTTLE HANDLE FOR RIGHT HAND Contains Stop Switch, Throttle Lockout, and Throttle Trigger.
- 3. THROTTLE TRIGGER LOCKOUT This lever must be held during starting. Operation of the throttle trigger is prevented unless throttle trigger lockout lever is engaged.
- 4. STOP SWITCH "SLIDE SWITCH" mounted on top of the throttle handle. Move switch FORWARD to RUN, BACK to STOP.
- 5. HAND GUARD / BLADE LOCK Locks blade in place for travel / storage. Always assure blade cover is installed when locking blade.
- 6. **BLADE INDEXING RING-** Pull ring out and turn 1/4 turn to lockout position when adjusting blade angle.
- 7. **BLADES** Double reciprocating blades mounted to a blade support bar. Double sided blades, are capable of cutting on either side.
- 8. **GEAR HOUSING ASSEMBLY** Gear housing contains drive gears for transmitting power to cutting blades. Pivoting design permits blades to articulate 180 degrees in 15-degree increments.
- 9. **BLADE ADJUSTMENT HANDLE** Provides secure hand grip for adjusting cutting blade angle.
- 10. SUPPORT HANDLE FOR LEFT HAND Grip for Left Hand.
- 11. DRIVE SHAFT ASSEMBLY Includes the flex drive shaft, throttle handle, harness ring, support handle, and safety decals.
- 12. THROTTLE TRIGGER Spring loaded to return to idle when released. During acceleration, depress gradually for best operating technique.
- 13. BLADE COVER Used to cover blade during transport and storage. Remove blade cover before using unit.
- 14. **SPARK PLUG** Provides spark to ignite fuel mixture.
- 15. **TOP GUARD** Protects arm from the hot engine.
- 16. SPARK ARRESTOR MUFFLER OR SPARK ARRESTOR MUFFLER WITH CATALYST The muffler or catalytic muffler controls exhaust noise and emission. The spark arrestor screen prevents hot, glowing particles of carbon from leaving the muffler. Keep exhaust area clear of flammable debris.
- 17. FUEL TANK Contains fuel and fuel filter.
- 18. RECOIL STARTER HANDLE Pull handle slowly until starter engages, then quickly and firmly. When engine starts, return handle slowly. DO NOT let handle snap back or damage to unit will occur.
- 19. FUEL TANK CAP Covers and seals fuel tank opening.
- 20. PURGE BULB Pumping purge bulb before starting engine draws fresh fuel from the fuel tank, purging air from the carburetor. Pump purge bulb until fuel is visible and flows freely in the clear fuel tank return line. Pump purge bulb an additional 4 or 5 times.
- 21. AIR CLEANER Contains replaceable filter element.
- 22. CHOKE CONTROL Located on the air cleaner housing. Move choke lever to COLD START ( ) to close choke for cold start. Move choke lever to "RUN" ( | | | | ) position to open choke.
- 23. **SHOULDER HARNESS** An adjustable strap that suspends the unit from the operator.

# **Gear Housing Assembly / Drive Shaft**

Note: Hedge Trimmer Blades are very sharp. Wear gloves to protect hands.

- 1. Remove locating bolt (A) and loosen clamping bolt (B).
- Remove vinyl cap from drive shaft.
- 3. Slide Gear Housing Assembly onto Drive Shaft. Be certain the Flex Drive Shaft engages the hole in Driver Gear.


#### NOTICE

Flat edge of washer (D) must be against drive shaft.

- 4. Align locating hole in gear housing with locator hole in drive shaft.
- Install locating bolt (A). Tighten clamping bolt (B).

# **Balance and Adjust Unit**

- 1. Loosen harness clamp screw.
- 2. Put on harness and attach unit to harness.
- 3. Slide harness clamp up or down for comfortable operation.
- 4. Tighten harness clamp screw.

#### Fuel

### **▲** WARNING

Alternative fuels, such as E-15 (15% ethanol), E-85 (85% ethanol) or any fuels not meeting ECHO requirements are NOT approved for use in ECHO 2-stroke gasoline engines. Use of alternative fuels may cause performance problems, loss of power, overheating, fuel vapor lock, and unintended machine operation, including, but not limited to, improper clutch engagement. Alternative fuels may also cause premature deterioration of fuel lines, gaskets, carburetors and other engine components.

#### **Fuel Requirements**

Gasoline - Use 89 Octane [R+M/2] (mid grade or higher) gasoline known to be good quality. Gasoline may contain up to 10% Ethanol (grain alcohol) or 15% MTBE (methyl tertiary-butyl ether). Gasoline containing methanol (wood alcohol) is **NOT** approved. ECHO brand Power Fuel™ is 93 octane, ethanol-free fuel premixed with ECHO Red Armor® engine oil at 50:1 ratio. Use of ECHO Power Fuel™ is recommended to extend engine life in all air-cooled 2-stroke and 2/4-stroke hybrid engines.

Two Stroke Oil - A two-stroke engine oil meeting ISO-L-EGD (ISO/CD 13738) and J.A.S.O. FD Standards must be used. Echo brand premium Power Blend X™ Universal 2-Stroke Oil meets these standards. Engine problems due to inadequate lubrication caused by failure to use an ISO-L-EGD (ISO/CD 13738) and J.A.S.O. FD certified oil, such as Echo premium Power Blend X<sup>™</sup>, will void the two-stroke engine warranty.

#### NOTICE

Echo premium Power Blend X™ Universal 2-Stroke Oil may be mixed at 50:1 ratio for application in all Echo engines sold in the past regardless of ratio specified in those manuals.

#### **Handling Fuel**

### **▲** DANGER

Fuel is VERY flammable. Use extreme care when mixing, storing or handling, or serious personal injury may result.

- · Use an approved fuel container.
- DO NOT smoke near fuel.
- DO NOT allow flames or sparks near fuel.
- Fuel tanks/cans may be under pressure. Always loosen fuel caps slowly allowing pressure to equalize.
- NEVER refuel a unit when the engine is HOT or RUNNING!
- DO NOT fill fuel tanks indoors. ALWAYS fill fuel tanks outdoors over bare ground.
- DO NOT overfill fuel tank. Wipe up spills immediately.
- Securely tighten fuel tank cap and close fuel container after refueling.
- Inspect for fuel leakage. If fuel leakage is found, do not start or operate unit until leakage is repaired.
- Move at least 3m (10 ft.) from refueling location before starting the engine.

#### Mixing Instructions

1. Fill an approved fuel container with half of the required amount of gasoline.

- 2. Add the proper amount of 2-stroke oil to gasoline.
- 3. Close container and shake to mix oil with gasoline.
- 4. Add remaining gasoline, close fuel container, and remix.

Stored two-stroke fuel may separate. ALWAYS shake fuel container thoroughly before each use.

# **Adjusting Cutting Angle**

#### **A WARNING**

Never adjust cutting assembly with engine running.

#### **WARNING**

Hedge Trimmer blades are sharp. Always wear gloves when adjusting cutting assembly.

#### **WARNING**

DO NOT stand hedge trimmer on end when adjusting cutting angle, otherwise serious injury may result.

- 1. Place unit on a flat clear area. Assure stop switch is in the "STOP" position.
- 2. Pull out indexing ring (A), and turn ¼ turn to lockout position.
- 3. Turn hedge trimmer ¼ turn so that indexing ring faces downward.
- 4. Release hand-guard blade lock (B) with right hand, while holding blade-adjustment handle (C) with left hand.

- 5. Rotate blades to desired cutting position.
- 6. Turn indexing ring ¼ turn to lock blade in place.




# **Rotate Cutter Assembly**



- 2. Rotate cutter assembly 180-degrees on driveshaft until locating hole in driveshaft is visible through locating hole in gearcase.
- 3. Install gearcase locating screw (C), and securely tighten all hardware.

- 1. Close choke (COLD START [ | ] position). This prevents dirt from entering the carburetor throat when the air filter is removed. Brush accumulated dirt from air cleaner area.
- 2. Remove air filter cover and air filter retainer from inside cover. Brush dirt from inside cover.
- 3. Replace filter if it is damaged, very dirty, or the rubber sealing edges are deformed.
- 4. Remove foam pre-filter and air filter and clean as indicated below:



- Clean foam filter in water/detergent solution and rinse with clean water.
- Wrap the filter in a clean, dry cloth and squeeze (do not wring) dry. Allow to dry completely before reuse. Do not oil.



- · Lightly brush debris from filter.
- Soak heavily soiled filters in water/detergent solution to loosen dirt, then brush lightly.
- Rinse with clean water and allow to dry completely before reuse.
- 5. Place foam pre-filter over raised center and inside outer lip of air filter. Install air filter in air filter case.
- 6. Install air filter retainer on post in air filter cover, flat side up.
- 7. Install air filter cover and tighten cover knob securely.







# **Cooling System**

Parts Required: None if you are careful.

#### NOTICE


To maintain proper engine operating temperatures, cooling air must pass freely through the cylinder fin area. This flow of air carries combustion heat away from the engine.

Overheating and engine seizure can occur when:

- Air intakes are blocked, preventing cooling air from reaching the cylinder.
- Dust and grass build up on the outside of the cylinder. This build up insulates the engine and prevents the heat from leaving.

Removal of cooling passage blockages or cleaning of cooling fins is considered "Normal Maintenance." Any failure attributed to lack of maintenance is not warranted.

# **Carburetor Adjustment**

#### **Engine Break-In**

New engines must be operated a minimum duration of two tanks of fuel break-in before carburetor adjustments can be made. During the break-in period your engine performance will increase and exhaust emissions will stabilize. Idle speed can be adjusted as required.

#### **High Altitude Operation**

This engine has been factory adjusted to maintain satisfactory starting, emission, and durability performance up to 1,100 feet above sea level (ASL) (96.0 kPa). To maintain proper engine operation and emission compliance above 1,100 feet ASL the carburetor <u>may</u> need to be adjusted by an authorized ECHO service dealer.

#### **NOTICE**

If the engine is adjusted for operation above 1,100 feet ASL, the carburetor must be re-adjusted when operating the engine below 1,100 feet ASL, otherwise severe engine damage may result.

- 6. Install blade cover on blades.
- 7. Tighten all the screws and nuts.
- 8. Drain fuel tank completely. Press purge bulb 6 -7 times to remove remaining fuel from carburetor then drain the tank again. Close choke, start and run the engine until it stops due to lack of fuel.
- 9. Allow the engine to cool, then emove the spark plug and pour 7 cc (1/4 oz.) of fresh, clean, two-stroke engine oil into the cylinder through the spark plug hole.
  - a. Place a clean cloth over the spark plug hole.
  - b. Pull the recoil starter handle 2-3 times to distribute the oil inside the engine.
  - c. Observe the piston location through the spark plug hole. Pull the recoil handle slowly until the piston reaches the top of its travel and leave it there.
- 10. Install the spark plug (do not connect ignition cable).

#### NOTICE

Always store and transport hedge trimmers in a stable, horizontal position. Support gear case and cutting blades to prevent excessive flexing, which may cause damage to these components. Always install blade cover when transporting or storing unit.
