


Extended Operation / Extreme Conditions


A CAUTION

Prolonged exposure to cold and/or vibration may result in injury. Read and follow all safety and operation instructions to minimize risk of injury. Failure to follow instructions may result in painful wrist/hand/arm iniuries.

It is believed that a condition called Raynaud's Phenomenon, which affects the fingers of certain individuals, may be brought about by exposure to vibration and cold. Exposure to vibration and cold may cause tingling and burning sensations, followed by loss of color and numbness in the fingers. The following precautions are strongly recommended, because the minimum exposure, which might trigger the ailment, is unknown.

- Keep your body warm, especially the head, neck, feet, ankles, hands, and wrists.
- Maintain good blood circulation by performing vigorous arm exercises during frequent work breaks, and also by not smoking.

Repetitive Stress Injuries (RSI)

Certain repetitive hand activities may put you at a high risk for developing a Repetitive Stress Injury (RSI). An extreme RSI condition is Carpal Tunnel Syndrome (CTS), which could occur when your wrist swells and squeezes a vital nerve that runs through the area. Some believe that prolonged exposure to vibration may contribute to CTS. CTS can cause severe pain for months or even years.

To reduce the risk of RSI/CTS, do the following:

- Avoid using your wrist in a bent, extended, or twisted position.
 Instead try to maintain a straight wrist position. Also, when grasping, use your whole hand, not just the thumb and index finger.
- Take periodic breaks to minimize repetition and rest your hands.
- Reduce the speed and force with which you do the repetitive movement.
- Do exercise to strengthen the hand and arm muscles.
- Immediately stop using all power equipment and consult a doctor if you feel tingling, numbness, or pain in the fingers, hands, wrists, or arms. The sooner RSI/CTS is diagnosed, the more likely permanent nerve and muscle damage can be prevented.



- Check that the cutting attachment is firmly attached and in safe operating condition. Dull, loose or damaged blades should not be used.

The emission control system for the engine is EM (engine modification) and, if the second to last character of the Engine Family on the Emission Control Information label (sample below) is "C", "K", or "T", the emission control system is EM and TWC (3-way catalyst). The fuel tank/fuel line emission control system is EVAP (evaporative emissions). Evaporative emissions for California models are only applicable to fuel tanks.

An Emission Control Label is located on the engine. (This is an EXAMPLE ONLY, information on label varies by engine FAMILY).

Product Emission Durability (Emission Compliance Period)

The 50 or 300 hour emission compliance period is the time span selected by the manufacturer certifying the engine emissions output meets applicable emissions regulations, provided that approved maintenance procedures are followed as listed in the Maintenance Section of this manual.





1. SUPPORT HANDLE - FOR RIGHT HAND - Comfortable, textured finish provides anti-slip grip. Guard protects hand from the blades. Warning decals are located on guard

- 2. THROTTLE TRIGGER LOCKOUT This lever must be depressed before Throttle Trigger can be activated.
- 3. THROTTLE HANDLE FOR LEFT HAND 5-position handle can be rotated right or left 45 or 90 degrees, and locked into position for a secure grip. Handle contains the Stop Switch, Throttle Lockout Lever, Handle Rotation Release Button, and Throttle Trigger.
- 4. THROTTLE TRIGGER Controls engine speed and resets Handle Rotation Release Button. Throttle Trigger Lockout must be fully depressed before Throttle Trigger will operate. Trigger returns to idle position when released. Squeeze trigger gradually for smooth acceleration.
- 5. **AIR CLEANER** Contains replaceable filter element.
- 6. **SPARK PLUG** Provides spark to ignite fuel mixture.
- 7. **BLADE GUARD-** Reduces risk of contact with blades and helps guide material into cutters.
- 8. **BLADES** Double reciprocating blades mounted to a blade support bar. The blades are double sided, capable of cutting on either side.
- 9. CHOKE The choke control lever is located on the front of the air cleaner case. Move choke lever to "COLD START" (] to close the choke for Cold Starting. Move choke lever to "RUN" (]] position to open choke.
- 10. PURGE BULB Pumping purge bulb before starting engine draws fresh fuel from the fuel tank, purging air from the carburetor. Pump purge bulb until fuel is visible and flows freely in the clear fuel tank return line. Pump purge bulb an additional 4 or 5 times.
- 11. SPARK ARRESTOR MUFFLER OR SPARK ARRESTOR MUFFLER WITH CATALYST -The muffler controls exhaust noise and emission. The spark arrestor screen prevents hot, glowing particles of carbon from leaving the muffler. Keep exhaust area clear of flammable debris.
- 12. FUEL TANK Contains fuel and fuel filter.
- 13. HANDLE ROTATION RELEASE BUTTON Push button in to release handle, then rotate handle to desired angle. Squeeze and release Throttle Trigger once to reset button and lock handle in new position.
- 14. STOP SWITCH "SLIDE SWITCH" mounted on top of the rear handle. Move switch FORWARD to RUN, BACK to STOP.
- 15. **FUEL TANK CAP** Covers and seals fuel tank opening.
- 16. **RECOIL STARTER HANDLE** Pull handle slowly until recoil starter engages, then quickly and firmly. DO NOT pull rope all the way out or allow the handle to snap back, damage to the starter will occur.
- 17. **BLADE COVER** Used to cover blades during transportation or storage. Remove blade cover before using unit.

ASSEMBLY

This model is factory assembled.

Note: For Normal cutting, Echo strongly recommends the blade guard be installed. In extreme conditions, such as commercial cutting or when cutting thick and/or dense branches, efficiency may be increased by trimming without the blade guard.








Install Blade Guard

3. Remove correct number of lock nuts (A) necessary to install blade guard. Assure blade bolts (B) are tightened securely.



- 4. Align holes in blade guard with blade bolts, then install blade
- 5. Secure blade guard with new lock nuts (A).

Note: Use new lock nuts every time blade guard is installed or removed.

Metal cutters can create sparks if the cutter strikes rocks, metal, or other hard objects. Contact local fire authorities for laws or regulations regarding fire prevention requirements.

Fuel

WARNING

Alternative fuels, such as E-15 (15% ethanol), E-85 (85% ethanol) or any fuels not meeting ECHO requirements are NOT approved for use in ECHO 2-stroke gasoline engines. Use of alternative fuels may cause performance problems, loss of power, overheating, fuel vapor lock, and unintended machine operation, including, but not limited to, improper clutch engagement. Alternative fuels may also cause premature deterioration of fuel lines, gaskets, carburetors and other engine components.

Fuel Requirements

Gasoline - Use 89 Octane [R+M/2] (mid grade or higher) gasoline known to be good quality. Gasoline may contain up to 10% Ethanol (grain alcohol) or 15% MTBE (methyl tertiary-butyl ether). Gasoline containing methanol (wood alcohol) is **NOT** approved. ECHO brand Power Fuel™ is 93 octane, ethanol-free fuel premixed with ECHO Red Armor® engine oil at 50:1 ratio. Use of ECHO Power Fuel™ is recommended to extend engine life in all air-cooled 2-stroke and 2/4-stroke hybrid engines.

Two Stroke Oil - A two-stroke engine oil meeting ISO-L-EGD (ISO/CD 13738) and J.A.S.O. <u>FD</u> Standards must be used. Echo brand premium Power Blend X[™] Universal 2-Stroke Oil meets these standards. Engine problems due to inadequate lubrication caused by failure to use an ISO-L-EGD (ISO/CD 13738) and J.A.S.O. <u>FD</u> certified oil, such as Echo premium Power Blend X[™], will void the two-stroke engine warranty.

NOTICE

Echo premium Power Blend X^{m} Universal 2-Stroke Oil may be mixed at 50:1 ratio for application in all Echo engines sold in the past regardless of ratio specified in those manuals.

Handling Fuel

A DANGER

Fuel is VERY flammable. Use extreme care when mixing, storing or handling, or serious personal injury may result.

- · Use an approved fuel container.
- DO NOT smoke near fuel.
- · DO NOT allow flames or sparks near fuel.

 Fuel tanks/cans may be under pressure. Always loosen fuel caps slowly allowing pressure to equalize.

- NEVER refuel a unit when the engine is HOT or RUNNING!
- DO NOT fill fuel tanks indoors. ALWAYS fill fuel tanks outdoors over bare ground.
- DO NOT overfill fuel tank. Wipe up spills immediately.
- Securely tighten fuel tank cap and close fuel container after refueling.
- · Inspect for fuel leakage. If fuel leakage is found, do not start or operate unit until leakage is repaired.
- Move at least 3m (10 ft.) from refueling location before starting the engine.

Mixing Instructions

- 1. Fill an approved fuel container with half of the required amount of gasoline.
- 2. Add the proper amount of 2-stroke oil to gasoline.
- 3. Close container and shake to mix oil with gasoline.
- 4. Add remaining gasoline, close fuel container, and remix.

After use

Storage - Fuel storage laws vary by locality. Contact your local government for the laws affecting your area. As a precaution, store fuel in an approved, airtight container. Store in a well-ventilated, unoccupied building, away from sparks and flames.

NOTICE

Stored fuel ages. Do not mix more fuel than you expect to use in thirty (30) days, ninety (90) days when a fuel stabilizer is added.

Stored two-stroke fuel may separate. ALWAYS shake fuel container thoroughly before each use.



Starting Cold Engine

Note: The blade cover is used for transportation and storage. Remove blade cover before using the unit.



Move stop switch (A) away from the STOP position.

2. Choke

Move choke (B) to COLD START (►) (closed) position.

3. Purge Bulb


Pump purge bulb (C) until fuel is visible and flows freely in the clear fuel tank return line. Pump bulb an additional 4 or 5 times.




Lay the unit on a flat, clear area. Grip the support handle securely with one hand, and pull the recoil starter handle (D) until engine fires (or 5 pulls maximum).

5. Choke

Note: If engine does not start with choke in "RUN" position after 5 pulls, repeat instructions 2 - 5.





WARNING

The blades must not move at idle, otherwise serious personal injury may result. Periodic carburetor adjustment may be necessary to assure blades do not move at idle. If blades move, readjust carburetor according to "Carburetor Adjustment" instructions in this manual or see your ECHO Dealer.

6. Throttle Trigger


After engine warm-up, grip the throttle handle and support handle. Depress the throttle trigger lockout, and gradually depress throttle trigger to increase engine RPM to operating speed.

Starting Warm Engine

The starting procedure is the same as Cold Start except DO NOT close the choke.

1. Stop Switch





- 3. Replace filter if it is damaged, fuel soaked, very dirty, or the rubber sealing edges are deformed.
 - · Lightly brush debris from filter.
 - Soak heavily soiled filters in water/detergent solution to loosen dirt, then brush lightly.
 - Rinse with clean water and allow to dry completely before reuse.
- 4. Install air filter in air filter case.
- Install air filter cover.



▲ DANGER

Fuel is VERY flammable. Use extreme care when mixing, storing or handling, or serious personal injury may result.

- 1. Use a clean rag to remove loose dirt from around fuel cap and empty fuel tank.
- 2. Use the "fuel line hook" to pull the fuel line and filter from the tank.

Spark Plug



Parts Required: REPOWER™ Tune-Up Kit

NOTICE

Use only NGK BPM-8Y spark plug (BPMR-8Y in Canada) otherwise severe engine damage may occur.

- 1. Remove spark plug and check for fouling, worn and rounded center electrode.
- 2. Clean the plug or replace with a new one. DO NOT sand blast to clean. Remaining sand will damage engine.
- 3. Adjust spark plug gap by bending outer electrode.
- 4. Tighten spark plug to 150-170 kgf cm (130-150 in lbf).



Level 2.

Parts Required: None if you are careful.

NOTICE

To maintain proper engine operating temperatures, cooling air must pass freely through the cylinder fin area. This flow of air carries combustion heat away from the engine.

Overheating and engine seizure can occur when:

- Air intakes are blocked, preventing cooling air from reaching the cylinder.
- Dust and grass build up on the outside of the cylinder. This build up insulates the engine and prevents the heat from leaving.


Removal of cooling passage blockages or cleaning of cooling fins is considered "Normal Maintenance." Any failure attributed to lack of maintenance is not warranted.

- 1. Remove muffler cover.
- 2. Remove starter cover and clean dirt and dust from fins.

NOTICE

DO NOT use a metal scraper to remove dirt from the cylinder fins.



- 1. Remove muffler cover.
- 2. Place piston at Top Dead Center (TDC) to prevent carbon/dirt from entering cylinder.
- 3. Remove exhaust guide (A), gaskets (B), and screen (C) from muffler body.
- 4. Clean carbon deposits from muffler components.

Note: When cleaning carbon deposits, be careful not to damage the catalytic element inside muffler.

- 5. Replace screen if it is cracked, plugged, or has holes burned through.
- 6. Assemble components in reverse order.


Parts Required: As needed: Heat Shield

- 1. Remove spark plug lead from spark plug, and remove engine cover.
- 2. Place piston at top dead center. Remove muffler (D) and heat shield (E).

Never use a metal tool to scrape carbon from the exhaust port. Do not scratch the cylinder or piston when cleaning the exhaust port. Do not allow carbon particles to enter the cylinder.

- 4. Inspect heat shield, and replace if damaged.
- 5. Install heat shield and muffler.
- 6. Tighten muffler mounting bolts (or nuts) to 70-80 kgf•cm (60-70 in•lbf).
- 7. Install engine cover and attach spark plug lead.
- 8. Start engine, and warm to operating temperature.
- 9. Stop engine, and re-tighten mounting bolts (or nuts) to specifications.

Carburetor Adjustment

WARNING

If blades move, readjust carburetor according to these instructions, or see your ECHO Dealer.

Engine Break-In

New engines must be operated a minimum duration of two tanks of fuel break-in before carburetor adjustments can be made. During the break-in period your engine performance will increase and exhaust emissions will stabilize. Idle speed can be adjusted as required.

High Altitude Operation

This engine has been factory adjusted to maintain satisfactory starting, emission, and durability performance up to 1,100 feet above sea level (ASL) (96.0 kPa). To maintain proper engine operation and emission compliance above 1,100 feet ASL the carburetor <u>may</u> need to be adjusted by an authorized ECHO service dealer.

NOTICE

If the engine is adjusted for operation above 1,100 feet ASL, the carburetor must be re-adjusted when operating the engine below 1,100 feet ASL, otherwise severe engine damage may result.



 - c. Observe the piston location through the spark plug hole. Pull the recoil handle slowly until the piston reaches the top of its travel and leave it there.
- 10. Install the spark plug (do not connect ignition cable).
